- A colored ribbon for the unit
- A multicolored, embroidered patch for each registered member (youth and adult)

Implementing the Program

The NJCOS administers the program through the region chair. Each unit may earn this recognition on its own merit for a particular calendar year, and may earn it for succeeding years, providing the yearly requirements are met. Units should aim to achieve all seven objectives; six objectives (the five required elements plus one of the additional requirements) must be met to qualify for the award.
